

MWWA OPERATOR EXAM PREREQUISITE COURSE

Concepts & Practices of Advanced Water Treatment Live In-Person Training

MWWA Course ID #EXM-2012-07

This MA Board of Certification approved course is required for anyone wishing to take the Grade 3 or 4 Water Treatment license exams. The course is taught over a 6-week period and covers advanced treatment concepts, including: source water protection and management, water chemistry, treatment processes and troubleshooting, important regulatory requirements, water sampling and laboratory procedures, advanced water treatment math, equipment operation and maintenance, safety, security and administrative duties.

Learning Objectives:

- Analyze and evaluate source water protection strategies and best management practices.
- Apply water chemistry principles to explain and troubleshoot common challenges in water treatment processes.
- Understand and troubleshoot processes such as coagulation, filtration and disinfection.
- Perform sampling and laboratory procedures according to regulatory standards.
- Demonstrate proficiency in advanced water treatment mathematics.
- Review the importance of safety, security and administrative duties.

Students must achieve a passing score of 70 points through a combination of attendance (cannot miss more than 3 hours of the course), homework, midterm exam and final exam. Upon successful completion of this course, a "Certificate of Completion" will be issued along with a Certificate for up to 34 Training Contact Hours (TCH).


