## Job Description

### Primary Duties/Responsibilities:

The Maintenance Technician/Operator will be responsible for performing the following after training and probationary period:

- A variety of basic operational and maintenance tasks relevant to maintaining safe and reliable operations of water treatment facilities and systems ensuring operational compliance with state and federal regulations.
- Routine cleaning and general housekeeping duties in work and plant areas as assigned, including but not limited to sweeping, dusting, mopping, painting, cleaning of plant, filter area and other process equipment and areas. Required tasks may also include landscaping duties as assigned including but not limited to mowing, brush cutting and trimming at the treatment plant and outlying stations.
- Enter daily data into Hach WIMMS
- After the training period, the shift will be from 3pm to 11pm, Monday to Friday, and will also cover for operator vacancies.



## Qualifications

### Education/Experience/Background:

- High school diploma or equivalent.
- 5 years of experience in the operation and maintenance of supply, pumping and water treatment facilities.

### Knowledge/Skills/Abilities:

- Good communications skills, both oral and written.
- Good organization, interpersonal, and problem solving skills.
- Ability to function in the digital world, using computer, laptop, tablet, smart phone devices and software to communicate and perform and record work.
- Basic knowledge of fundamentals of chemistry, math principles and hydraulics required.
- Ability to use CMMS to schedule and complete work orders.
- Ability to collect water quality samples, test and maintain collection records.
- Perform all job responsibilities and duties in compliance with all safety, health, environmental, and security laws, rules, policies, programs, and training.
- Performs similar or less skilled work as assigned.

### Required Certification/Licenses/Training:

- Massachusetts DEP Grade 3 treatment license OIT or a Grade 2 full treatment license with the ability to obtain the grade 3 within 12 months of hire.
- Must possess and maintain a valid state driver's license.

### Physical Requirements:

- Ability to transport up to 50 lbs. in repetitive motions, operate in inclement weather, and enter/exit manholes.
- While performing the duties of this job, the employee is regularly required to talk or hear.
- The employee is frequently required to stand; walk; climb stairs or ladders; sit; use hands to finger, handle, or feel; reach with hands and arms; climb or balance; stoop, kneel, crouch, or crawl and taste or smell.
