Summary:

Performs work associated with the daily operations with the water distribution and treatment facilities, wells and related appurtenances.

Qualifications and Experience:

Education:

- High school education or G.E.D. or equivalent. Training will be provided to the ideal candidate.

Experience and Knowledge:

- Preferred knowledge in Electrical, Mechanical, HVAC, Instrumentation and Computer knowledge a plus.
- Requires a 30-minute response time to West Bridgewater, during rush hour.

Essential Functions:

- Basic skills in minor electrical, plumbing, HVAC and Building Maintenance.
- Ability to participate in the construction and repair of water mains, fire hydrants, water service repairs. Installation and read meters, along with associated plumbing.
- Must successfully pass an employee physical prior to beginning work for the Town and be subject to random DOT drug testing.

Supervision:

- Works under direct supervision of Water Superintendent.

Job Environment:

Applicant works under field conditions and in extreme weather conditions.

Applicant must use and wear personal protective equipment and clothing such as hearing protection, eye protection, foot and hand protection, respiratory protection.

Physical Requirements:

Frequent strenuous physical effort required ability to lift and carry on a frequent and continuous basis, weights of 50 to 100 pounds.
